

TERMS AND CONDITIONS OF BUSINESS

PRICING

All prices quoted on the website are in GB Pounds, and include any UK VAT and Excise Duty payable. If you are ordering from outside of the UK, please be aware that current exchange rates fluctuate, and that your card provider, or Paypal will calculate their own exchange rate. We are not liable for any change in exchange rate, or for any charges that your card provider or Paypal may charge you. If you are ordering from outside of the UK please be aware that you may be liable for any local tax and excise duties in your country. It is your responsibility to be check this prior to purchase.

DELIVERY

We can send your order to any address which you require, we cannot send to PO Boxes as all packages will need to be signed for by persons aged over legal drinking age. Proof of I.D may be asked for upon delivery.

Normal delivery time is 3 working days, and working days are counted as Monday-Friday, excluding Bank Holidays. If you order after 4pm, we will count the next working day as the first working day for delivery.

Sometimes due to high demand, such as large orders, or peak times such as Christmas, deliveries may take a little longer. If we are aware of any delays to your order we will aim to contact you by email to inform you of this. If you want to check on the status of your order, you can contact us on info@thelickerishtooth.com quoting your order number and we can provide an update.

We accept no responsibility for goods required by a specific date that fail to arrive due to circumstances beyond our control. We always do our best to fulfil your requests, and endeavour to meet demand, but please allow plenty of time for time-critical items, especially around busy times like Christmas.

EXPORTS

We currently operate from offices in the UK, and therefore operate under the laws of England and Wales.
